

Argusville City Council Regular Meeting

July 6, 2015

Mayor Lyson called the meeting to order at 7:02 PM with the following in attendance: Dave Becker, Wayne Hagemeister, Cheri Wetzel, Jeremy Dewald, Deputy Jeff Arth, and Mary Howatt. Absent: Rod Clouse, Randy Teberg.

M Becker-Hagemeister to approve June minutes. Carried. June finance report approved as presented.

Teberg joined meeting.

Dewald requested approval to do a proposal for a feasibility study for potential water-sewer extension by the football field. Discussion held. M Teberg-Becker to direct Dewald to do a proposal. Carried.

Lyson reported on school upkeep. Parking lot post installation is scheduled for completion this week. Teberg reported on yard waste issues. Notice will go out on necessary changes. Teberg will check on signage.

M Hagemeister-Becker to approve variance at 912 Sugar Drive. Carried.

Due to ND Senate Bill 2369, local liability for 2011 event will be reduced. ND Department of Emergency Services will reimburse \$138.68 to city for DR 1981 (2011).

Ordinance enforcement discussion. County deputies can enforce county ordinances or charge disorderly conduct in some instances. Lyson will research community enforcement procedures and regulations.

Fireworks ordinance – tabled to August.

Request from 209 3rd Street to remove or seed over sidewalk. M Becker-Teberg to allow removal. Carried.

Request from residents to install Little Free Libraries on their properties. Acceptable if set back five feet from lot line.

M Becker-Teberg to set auditor bond at \$250,000. Aye: Becker, Hagemeister, Teberg. Absent: Clouse. Carried.

Teberg reported two lift stations needed maintenance due to high levels of cooking grease. Notice will be sent to residents to discontinue dumping grease.

Deputy Arth reported on local activity.
