## **Community Reports**

• Community Center Floor Cleaning: AFD is going to purchase a floor cleaner for the community center. They are asking if the city would like to pitch in 1/3 of the cost, \$1,340.00. M Clouse Vander Wal. Carried.

Deputy Report – No report

Engineer Report – Lead and copper Lines: Al Woods provided update that three service lines contain copper and lead pipes. The city can get money to replace these pipes.

Flood Preparation: Wetzel and Clouse attended flood meeting in Harwood and provided update. Harwood has a 10% chance of 92.1 feet and a 25% chance of 91.8 fee. In 2009 the levels were at 91.8 feet and there was no water over County 4. Crest is expected around April 17<sup>th</sup> to the 24<sup>th</sup>. The city has over 5,000 sandbags on hand that have been stored inside and out of the sun. The water pumps have been serviced and are ready to use. Lovejoy will set the pump up at Richwood.

- Declare Flood Emergency (see attached): M Clouse Saewert. Carried.
- Set Wages for Flood Emergency Plan- Saewert noted that the city can set wages to pay for flood expenses. Discussion was held around FEMA's current wages versus what the city would like to set. At this time, no decision was made to set any wages.

Spring Clean Up: Saewert contacted WM and they have an available date of May 25<sup>th</sup>. Lovejoy raised concerns over the ground being wet still. A second date of June 8<sup>th</sup> is available, and a decision was made to go with this date. Continue to help with cleaning up to city residents if needed.

Memorial Donation: Hold off on discussions for setting up a memorial to see if the school will be doing anything. If the school does, the city will discuss further on chipping in.
